CONDITIONS OF SALE

1. The sale is made by AFFIN BANK BERHAD (“the Assignee/Bank”) in the exercise of the rights and powers conferred upon the Assignee in pursuance of the **Deed Of Assignment And Power Of Attorney Both Dated 12th Day Of August 2002** executed by **ZAMRUT SURIA BIN SOBRI** (“the Assignor/Borrower”) in favour of the Assignee and is made subject to all conditions and category of land use, expresses or implied or imposed upon or relating to or affecting the subject property.
2. Subject to the Reserve Price, the highest bidder being so allowed by the Auctioneer/Assignee shall be the Purchaser but the Auctioneer/Assignee shall have the right to refuse any bid. If any dispute shall arise as to any bidding, the property shall at the option of the Assignee be put up again for sale or Auctioneer/Assignee may decide the dispute without a resale.
3.
